#### **Our Infrastructure and Facilities (At the present temporary venue)**

- ❖ Library with Lending, Reference & Reading Room Facilities
- Compilation of scripts of plays
- College shall try to provide shared accommodation on temporary basis as required.

#### **GENERAL RULES**

- 1. Students must attend classes in time and under no circumstances, leave the classroom without the permission of the class teachers. Irregular attendance may result in their being struck off from the registers.
- 2. The student should collect their caution money within a period of six months after completion of the course of study, failing which the money will be forfeited and deposited in the Government Treasury.
- 3. Serious action will be taken against any student found taking part or associating in any way with disorderly proceedings within the College premises.
- 4. Every student shall carry on regularly his/her identity card issued by the College immediately after admission and get the same renewed every year.
- 5. Students have to maintain proper decorum, to follow the rules and regulations of the Institute, and to pay due respect to the Faculty and other officials.
- 6. Damage to the College property (fixtures, fittings, instruments, furniture, books/periodicals, vehicles, building, etc.) shall be viewed seriously and might result in instant expulsion of the guilty students from the College.
- 7. The students are expected to have 100% attendance at classes. However, a minimum of 75% attendance is essential as per the regulation of the Goa University. Students must appear for ISA & SEA (Theory & Practical) Examinations conducted by the College, failing which he/she will not be allowed to appear for the University/College Examination.
- 8. The Ragging is banned in the College and any one found indulging in "ragging", is likely to be punished, which may include expulsion from the College.
- 9. Students are required to strictly abide by the code of Conduct and any lapse will be dealt with according to the rules and regulations of the College/University.
- 10. In case of damage of furniture, Instruments/equipments of the College/Kala Academy Goa, the cost of repairs or replacement will be charged to the student responsible for the damage. The management may impose collective fines to compensate for any such damage.
- 11. Students must keep their guardians informed of their progress by updating them about their performance in the regular assignments/tests, etc. Parents and guardians must realise that the training of their wards is their joint responsibility and check the progress, conduct, regularity of their wards through their respective teachers personally. Parents must come to meet the Principal without fail whenever they are called.

- 12. All parents/guardians shall witness the productions of college of Theatre Arts from time to time to check and test the progress of their pupil.
- 13. Consuming alcohol, tobacco in the college premises is strictly prohibited.
- 14. Students are not allowed to invite visitors or friends to classes, lectures or rehearsals.
- 15. It is obligatory for the students to participate in any allotted capacity in the practical areas of the curriculum.
- 16. Students violating rules are liable to severe disciplinary action.

#### Do's

- ➤ Do carry/wear your identity card at all times. You may be asked to leave the campus if you don't. Apply for a duplicate I-card incase yours is lost.
- ➤ Do be on time for all your lectures/practical. You may not be allowed to enter the classroom/labs late.
- ➤ Do take care of the college property and keep it clean and tidy.
- ➤ Do submit your filled in justification form in case you remain absent for lectures/practical/I.S.A.s within three days of your rejoining the college.
- ➤ Do read the Notice Board and visit the College website regularly.
- ➤ Do meet the Principal in case you have any problem or grievance pertaining to the college.
- > Do participate in the co-curricular activities of the college during your spare time.
- > Do be courteous to other students and to all the teaching and administrative staff.
- > Do maintain respectful and responsible behavior at all time.

#### Don't's

- ➤ Do not use unbecoming/indecent language or conduct in the class/campus. This may lead to suspension or dismissal.
- ➤ Do not attend lectures other than your own, except with special permission from the lecturer concerned.
- > Do not damage the fixtures and fittings in the college campus.
- > Do not smoke, consume liquor, drugs or other intoxicants.
- ➤ Do not use mobile/cell phones in the classrooms, laboratories and library.
- ➤ Do not talk/discuss/create disturbance in the Library.

#### LIBRARY RULES FOR STAFF AND STUDENTS

1. The borrowing facility of library resources is open to the students, teaching as well as non-teaching staff of the college. The entitlement of borrowers is as follows

#### Delayed returns attract a late fee of Rs. 2/- per day per book.

- 2. The books already issued may be renewed in absence of demand by others.
- 3. The borrower must check the condition of the book and report unusual occurrences while borrowing itself. Else, the borrower will be solely responsible for any damage spoilage or mutilation of the book. The borrower will be charged for the repair or replacement of book and other library material if found damaged.
- 4. If the borrower loses any book or other material issued to him/her, the same must be reported to the Librarian immediately. If the book cannot be found within a sufficient period on case to case basis, then the borrower has to replace the book with the latest edition or book amount plus a fine. Replacement of a book by its photocopy is not permitted.
- 5. Library members found disfiguring the books and tearing/removing pages from the Books/Magazines/Questions Papers or found in possession of torn pages will be penalized by cancellation of their membership of the library and by imposing a fine to cover double the cost of the Books/Magazine/Questions Papers.
- 6. The librarian reserves right to recall a borrowed book any time without giving any reason from the borrower.
- 7. Library material that is not borrowed on entitlement, cannot be taken out of the library.
- 8. Members are advised not to leave cash and other valuables in the Library. The library shall not be responsible for such losses.
- 9. Re-shelving of used library materials will be done by the library staff only.
- 10. For reserving a book that is borrowed by someone else, the student must give requisition to the staff at issuing counter.
- 11. The following categories of documents will not be issued to take home but can be referred in the library: Dictionaries, Encyclopedia, Handbooks, Newspapers.
- 12. Eatables & Beverages are not allowed inside the library.
- 13. Utmost silence has to be observed in the library. Speaking on a cell phone in the library is strictly prohibited. Please leave the library in case you desire to speak over the phone.
- 14. Textbooks, printed materials and issued books are not allowed to be taken inside the library
- 15. Enter your name and sign in the register kept at the entrance counter before entering the library
- 16. No personal belongings are allowed inside the library
- 17. An identity card is compulsory for getting access to the library
- 18. Using Mobile phones and audio instruments with or without speaker or headphone in the library premises shall be allowed only with the prior permission of the librarian or library staff.
- 19. Each student shall obtain No dues certificate from the library after returning all the books issued, surrendering the borrower's cards and after paying outstanding dues, if any, at the end of the academic year.

The syllabus of Bachelor of Performing Arts (Theatre) Programme has been prepared by Board of Studies in Performing Arts (Theatre) and approved by the Academic Council of Goa University. It includes Dramatic Literature and Theatre History, Stage Craft and Theatre Techniques, Acting, Direction and Departmental Play Production.

The main thrust is on the participation of the production process itself. However, the aim is to give students exposure to the complete milieu of Theatre.

The four year is divided into 8 semesters.

Programme structure of BPA(Theatre) Semester I & II has been approved by the Goa University as per the circular No. GU/Acad-PG/BoS-NEP/2023/102/14 dt. 23/06/2023.

If a student chooses to withdraw from the programme of study in which he/she is enrolled, the following four tier system shall be followed for the refund of fees remitted by him/her.

- # In case of (1) in the table above,10% of the aggregate fees shall be deducted as processing charges from the refundable amount.
- a) Fees shall be refunded to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard.
- b) The students who have already been admitted to a programme of the University and have paid the fees and are subsequently admitted to another programme shall have to pay the fees for the final admission and claim the refund of fees paid earlier, in which case no administrative charges shall be deducted from fees paid earlier by the student.
- c) All other cases of the refund of the fees will be decided on case to case basis in its merit.

## UGC REGULATIONS ON CURBING THE MEANCE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, 2009.

(Under Section 26 (1) (g) of the University Grant Commission Act, 1956) Dated June, 2009

#### **PREAMBLE**

In view of the Directions of the Hon'ble Supreme Court in the matter of "University of Kerala" V/S Council, Principals, Colleges and others" in SPL no.24295 of 2006 dated 16.05.2007 and that dated 08.05.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government and the University Grant Commission to Prohibit, prevent and eliminate the courage of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or in disciplined activities by any student or students, which causes or likely to cause annoyance, hardships or psychological harm or to raise fear or apprehension thereof in any fresher or any other students, or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of sane, torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student with or without an intent to derive as a distic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institution in the country, and thereby, to provide for the healthy development, physically or psychologically, of all students, the University Grant Commission, is consultation with the Councils, brings forth this Regulation.

In exercise of the powers conferred by clause(g) of sub-section(1) of section 26 of the University Grants Commission Act, 1956, the University Grant Commission hereby makes the following Regulations, namely

#### What constitutes Ragging?

- a. Ragging constitutes one or more of any of the following acts: a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b. Indulging in rowdy or in discipline activities by any student or student which cause or likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c. Asking any student to do any act which such student will not in the ordinary course to do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.

- d. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- g. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- h. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- I. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

#### Administrative action in the event of Ragging:

## The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under:

- a) The Anti-Ragging committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:
  - I. Suspension from attending classes and academic privileges.
  - II. Withholding / withdrawing scholarships / fellowship and other benefits.
  - III. Debarring from appearing in any test / Examination or other evaluation process.
  - IV. With holding results.
  - v. Debarring from representing the institution in any Regional, National or International meet, tournament, youth festival, etc.
  - VI. Suspension / expulsion from the hostel.

- VII. Cancellation of admission
- VIII. Rustication from the institution for a period ranging from 1 to 4semesters.
- IX. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
- x. Fine which may extend upto 2.5 lakhs. Provided that where the person committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
- c) An appeal against the order of punishment by the Anti-Ragging Committee shall lie
  - i. In case of an order of an institution, affiliated to or constituent part, of a University to the Vice-Chancellor of the University;
  - ii. In case of an order of a University, to its Chancellor.
  - iii. In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case maybe.
